Your personal data will not be subject to automated decision processes or transferred to third countries. Data may also be managed by external data processors, exclusively for purposes strictly related to the management of the contractual relationship, as established by current legislation. Data processors are contractually bound to the legitimate and proper use of data. The updated list of Data Processors can be consulted at the Data Controller's registered office. Your data are processed for the purposes listed below, with the legal basis indicated below:

Your data may be sent to the Data processors or categories of data processors listed below:

Data processors categories:

Consultants and freelancers in individual or associated form, Banks and credit institutions, Companies and enterprises (Companies operating in the field of logistics), Consultants for certifications, insurance companies, non-economic public authorities.

In addition to this information, in order to ensure that your data is processed as fairly and transparently as possible, you must know that:

- in relation to contractual obligations, the ten-year prescription period applies in case of default. The period of data storage is 10 years from the end of the contract.
- You have the right to ask to the data controller to access your personal data and rectify or erase them or their portability or limitation of the processing that concerns you or to oppose at their processing in cases provided by law;
- if you have given your consent for one or more specific purposes, you have the right to revoke your consent at any time;
- has the right to file a complaint with the following Control Authority: Italian Data Protection Authority;
- you have a legal obligation to provide the requested personal data. Their treatment is, in fact, necessary for the management of the contractual relationship, in accordance with current legislation on the subject.

The rights indicated can be exercised by written communication that you can sent by PEC or registered letter with return receipt to the address of the Data Controller mentioned above.
